#### Overview:

Teaching Associates (TAs) typically are responsible for providing classroom and/or laboratory instruction, making assignments to students, preparing course materials, administering examinations, assessing student performance, tutoring students and determining course grades. Also, incumbents may assist faculty with field experience, supervision, simulation exercises and/or research projects. Students applying for TA positions must be currently enrolled in the graduate program of the department in which they are applying. Degree-seeking graduate students who are enrolled in interdisciplinary degree programs may be hired as TAs for departments that comprise their interdisciplinary programs. Academic Student Employees may not concurrently hold a faculty or staff position. Students with assignments in more than one student classification (i.e., Graduate Assistant, Instructional Student Assistant, and Student Assistant) are restricted to working a maximum of 20 hours per week during the academic year. ### Job Duties:

Appointments are for a single term (Fall or Spring). Fall appointments may be renewed for the Spring semester dependent upon budget, enrollment, and satisfactory performance. Positions are available in:

- Providing instructional support in Kinesiology courses
- Human Performance Lab (HPL): Oversight and instruction of fitness evaluations and interpretation of testing protocols. Maintain data bases of testing results.
- Biomechanics Lab: Oversight and instruction of labs for courses (KINS 380, 484, 655). Preparation, oversight and instruction using specific equipment.
- Physical Activity Instruction: Teach physical education activity courses in soccer, badminton, tai chi, golf and other fitness activities.
- Research Support: Provide specific support for department research activities.

### Minimum Qualifications for this Classification:

<u>Knowledge and Abilities:</u> Knowledge of the subject matter of the discipline to which the individual is assigned. Ability to relate well to others within the academic environment and ability to instruct and evaluate students.

<u>Education</u>: Education equivalent to or completion of the requirements for a bachelor's degree and concurrent admission to or enrollment in a graduate degree program of the university in the discipline to which the individual is assigned.

Experience: Evidence of satisfactory achievement in previous academic work.

Note: Exceptions to the minimum eligibility qualifications may be granted at the sole discretion of Humboldt State University.

Successful applicants will be notified in writing by the Department Chair. Positions are offered generally at the beginning of the academic year for a start in fall semester.
